FIRST AMENDMENT TO THE KONA PACIFIC PUBLIC CHARTER SCHOOL JULY 1, 2021 PUBLIC CHARTER SCHOOL CONTRACT

I. Background

This FIRST Amendment to the July 1, 2021 Public Charter School Contract (the "Amendment") effective as of March 9, 2023 (the "Effective Date"), is by and between the **STATE PUBLIC CHARTER SCHOOL COMMISSION** located at 1164 Bishop Street, Suite 1100, Honolulu, Hawaii, 96813 (the "Commission"), and **KONA PACIFIC PUBLIC CHARTER SCHOOL** ("School"), whose mailing address is P.O. BOX 729, Kealakekua, Hawai'i 96750, (the "School"), (collectively the "Parties").

WHEREAS, at the January 10, 2020 General Business Meeting, the Commission approved the Charter Contract (version 4.0) with KONA PACIFIC PUBLIC CHARTER SCHOOL for a five-year term effective as of July 01, 2021 through June 30, 2026; and

WHEREAS, on November 28, 2022, KONA PACIFIC PUBLIC CHARTER SCHOOL requested a First Amendment to the Charter Contract to amend Section 2.2 Mission Statement; and

WHEREAS, on March 9, 2023, the Commission unanimously passed a Motion to approve the School's request to amend the Charter Contract to amend Section 2.2 Mission Statement; and

WHEREAS, effective March 9, 2023, the parties agree to amend the July 01, 2021 Public Charter School Contract and to the following changes set forth in this First Amendment, it is hereby understood and agreed as follows,

II. Amendments

The following amendments to amend the mission statement, are agreed to by the parties and revised from the July 01, 2021 Public Charter School Contract, in the corresponding section referenced below:

Section 2.2 Mission Statement

Kona Pacific Public Charter School strives to educate the whole child. We prioritize a high level of academic excellence, social emotional well-being, and enthusiasm for learning through an academic standards-based curriculum infused with Waldorf-inspired practices, Hawaiian culture and 'Āina based education through our sustainable agriculture program.

This FIRST Amendment to the **KONA PACIFIC PUBLIC CHARTER SCHOOL** July 1, 2021 Public Charter School Contract, along with the attached original Charter Contract forms the entire agreement between the Parties. Except as otherwise expressly provided in this Amendment, all of the terms or conditions of the July 1, 2021 Charter Contract remain unchanged and in full force and effect.
